2. SWEEPSTAKES ENTRY PERIOD: Sweepstakes begins on March 17, 2025, at 12:00 a.m. Central Time (“CT”) and ends on April 28, 2025, at 11:59 p.m. CT (“Sweepstakes Entry Period”). Sponsor’s or its agency’s computer system will be the official timekeeper of the Sweepstakes.

3. ELIGIBILITY: Sweepstakes is open to legal residents of the 50 United States and the District of Columbia who are 18 years of age or older at time of entry. Employees and their immediate family members of Lamb Weston, Inc., Warner Bros. Entertainment Inc., Fandango, Poppin’ Jay, Inc. d/b/a Blue Chip, Ventura Associates International LLC (“Administrator”), their respective parent companies, affiliates, subsidiaries, advertising/promotion agencies involved in this Sweepstakes (collectively, the “Sweepstakes Entities”) are not eligible to participate or win. Void where prohibited by law. Sweepstakes is subject to all applicable federal, state and local laws.

b) Visit www.GrownInIdahoSweeps.com (“Website”), follow the onscreen instructions to submit your information including uploading the scan or picture of your receipt. You will earn one (1) entry in the Sweepstakes regardless of how many Grown In Idaho products purchased on that receipt. See entry limit below.

Grown In Idaho products can be found at many retailers and online retailers throughout the United States. Sponsor is not responsible for its product availability at any retail store or on any website.

Mail-in method: no purchase required:

Sponsor is not responsible for entries or receipts that are garbled, damaged, late, illegible, deleted or misdelivered. Entries using bots or other forms of automatic entry will be disqualified. Multiple entrants are not permitted to share the same email address. Sponsor may prohibit an entrant from participating in the Sweepstakes or winning a prize if, in its sole discretion, it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, deceiving or using other unfair playing practices or otherwise violating these Official Rules. Notice of any such cancellation, modification or suspension may be posted on the Website. The "Authorized Account Holder" is defined as the natural person to whom the email address is assigned by an online service provider or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address.
